- Leads the development of detailed project documentation and presentations using project management methodology, tools and quality management techniques.
- Prepares detailed schedules of activity for a wide cross section of projects and monitors, measures and reports outcomes against project deliverables and benefits.
- Works closely with the Manager, Planning Reform and Project Director, ePlanning and other members of the project management team to ensure the program of works is in line with the agreed scope and expectations of the stakeholders and business and that benefits are delivered as expected.
- Collaborates with internal and external stakeholders to ensure appropriate levels of integration between Planning Reform projects and associated ePlanning projects to ensure that all dependencies are understood and appropriately managed to meet the required outcomes.
- Collaborates with the Manager, Planning Reform in the development of a detailed benefits realisation plan and the implementation of strategies to ensure benefits are appropriately delivered.
