Role Overview

The Safety Management Officer is directly responsible and accountable for implementing and driving safety change and initiatives, adopting the standards required, updating policies, ensuring employees were cognisant of their role in achieving a coordinated and consistent approach to safety and risk. The Safety Management Officer would make sure this is done in a collaborative approach with a single point of contact for all elements of safety to tie together across Facilities Services.

Key Outcomes of the Role

The Safety Management Officer is required to undertake a wide range of activities which may include all or any of the following:

- a. Initiating, planning and delivering significant assigned safety programs, projects, systems and/or services that are consistent with the agency's objectives, including coordinating the implementation of change initiatives.
- Coordinating the resources and implementation processes for sensitive, innovative, critical or complex service wide operations that demand a significant level of responsibility and decision making.
- c. Managing and motivating staff, clients and others in the achievement of difficult and sometimes conflicting objectives.

- d. Resolving complex issues with innovative solutions that are consistent with Agency objectives.
- e. Providing expert advice to senior management and external stakeholders regarding current relevant developments and their potential implications to agency policies and strategic plans.
- f. Leading, where required, high level research and analysis of complex and sensitive issues and/or policies.
- g. Contributing to a safe, diverse and healthy work environment free from discrimination and harassment by working in accordance with legislative requirements, the <u>Code of</u> <u>Ethics for the South Australian Public Sector</u>, equal employment opportunity and departmental human resource policies, including Work Health Safety and Wellbeing requirements.
- h. Contributing to a high standard of customer service for internal and external clients and quality management and risk.
