Organisation Overview

The Department of Planning, Transport and Infrastructure (DPTI) serves the South Australian community by providing safe, effective and efficient planning, transport and infrastructure networks across the state and facilitating development of the State's Infrastructure, in accordance with South Australia's Strategic Plan and the State Infrastructure Plan.

DPTI is a values based organisation and relies on its people to live the values through positive behaviours to improve outcomes for employees and all South Australians.

Division

Safety and Service Division comprises four directorates: Asset Management, Transport Operations, Regulation and Road Safety. It is the primary delivery and operational arm of transport, maintenance and infrastructure across the department.

This role forms part of the Road Safety Directorate.

The Road Safety Directorate's primary role is to maintain a focus on how we think, frame and invest in road safety for South Australia. People make mistakes and the transport system must accommodate for these. A mistake should not result in death or serious injury. We provide leadership and subject matter expertise on the countermeasures available to reduce the impact and severity of injury. Our aim is to reduce our annual road toll to less than 80 fatalities and 800 serious injuries by 2020.

Role Overview

The Senior Road Safety Engineer is accountable to the Road Safety Infrastructure Programs Unit Manager within the Safety Strategy Section for:

- Providing "Safe System" engineering expertise to road safety projects in accordance with accepted standards, guidelines and policies.
- Establishing objectives, eligibility criteria and assessment methodology for road safety • infrastructure projects.
- Incorporating relevant research findings, new measures and practices to road safety infrastructure projects.
- Undertaking evaluation and monitoring of road safety infrastructure programs. •

- Developing business cases for road safety infrastructure programs.
- Ensuring that communication and consultation with relevant external bodies and stakeholders is established and maintained, including the development of formal project reporting mechanisms.
- Providing expert advice to internal and external stakeholders on relevant engineering issues.

Key Outcomes of the Role

The Senior Road Safety Engineer is required to undertake a wide range of activities which may include all or any of the following:

- a. Providing expert input into the development of professional standards, objectives and priorities of assigned programs, projects, assets, systems and/or services that deliver DPTI's objectives, including the implementation of change initiatives.
- b. Planning and managing complex projects where required, including determining and allocating resources and work priorities and motivating staff to ensure standards and efficiencies are met.
- c. Undertaking professional duties of an innovative and/or crucial nature including research, analysis and reporting relating to the resolve of complex issues and the management of assigned programs, projects, assets, systems and/or services.
- d. Preparing complex technical documents and correspondence for assigned programs, projects, assets, systems and/or services.
- e. Providing specialised input and advice to management and stakeholders regarding current relevant discipline developments, practices, technologies, policies and issues related to assigned programs, projects, assets, systems and/or services.
- f. Managing critical, sensitive and/or complex information and consultation processes with stakeholders and across government agencies.
- g. Contributing to a safe, diverse and healthy work environment free from discrimination and harassment by working in accordance with legislative requirements, the <u>Code of</u> <u>Ethics for the South Australian Public Sector</u>, equal employment opportunity and departmental human resource policies, including Work Health Safety and Wellbeing requirements.
- h. Contributing to a high standard of customer service for internal and external clients and quality management and risk.

Special Conditions and Essential Requirements

Some work outside normal hours and both intrastate and interstate travel involving overnight absences may be required.

This role has been classified as a position of trust. The incumbent is subject to a satisfactory criminal history / record check in line with departmental policies and procedures.
