I refer to your internal review application made pursuant to section 29 of the *Freedom of Information Act 1991* (the FOI Act) on 12 April 2023.

Your application for review of the initial determination indicates that you feel aggrieved because the 30-day period for processing your application has now passed. A determination was due on 3 April 2023. This means that this agency is deemed by section 19(2)(b) of the FOI Act to have refused access to the documents requested.

I have made the following determination on internal review.

There are thirty-five (35) documents that fall within the scope of your application and are those that are listed in the attached document schedule.

I have determined to release six (6) documents in full (Documents 01b -01d, Document 06a, Document 13 and Document 15), partially release fifteen (15) documents in accordance with Section 20(1)(a) and Clause 6(1) of Schedule 1 of the FOI Act, and refuse release fourteen (14) documents in accordance with section 20(1)(a) and 20(1)(b); Clauses 9(1) and 17(c) of Schedule 1 of the FOI Act which states:

20—Refusal of access

- (1) *An agency may refuse access to a document—*
- (a) *if it is an exempt document; or*
 - (b) *if it is a document that is available for inspection at that or some other agency (whether as part of a public register or otherwise) in accordance with Part 2, or in accordance with a legislative instrument other than this Act, whether or not inspection of the document is subject to a fee or charge;...*

6—Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

9—Internal working documents

(1) A document is an exempt document if it contains matter—

(a) that relates to—

(i) any opinion, advice or recommendation that has been obtained, prepared or recorded; or

(ii) any consultation or deliberation that has taken place, in the course of, or for the purpose of, the decision-making functions of the Government, a Minister or an agency; and

(b) the disclosure of which would, on balance, be contrary to the public interest.

Clause 6(1)

Document 01e, Documents 03a-03g and Documents 04a-04g contain information that I consider to be the personal affairs of an individual, the release of which would involve the unreasonable disclosure of their personal affairs. I therefore determine the information to be exempt from disclosure under clause 6(1) of Schedule 1 of the FOI Act.

Clause 9(1)

Document 05, Document 06b, Document 07, Document 08, Document 09, Document 10, Document 11, Document 12 and Document 17 contain opinions and advice prepared by the agency for the purpose of the decision-making functions of the Minister. These documents are considered exempt under clause 9(1)(a)(i) Schedule 1 of the FOI Act.

In considering the grounds for exemption of information under clause 9, I have considered the public interest in disclosure or non-disclosure:

Factors in favour of release:

- further the objects of the FOI Act; and
- promote openness and accountability of the agency and its staff.

Factors against release

- enable the free and frank discussion of opinions and advice;
- ensure the effective conduct of government functions;
- draft documents are not complete works and do not contain, or have had applied, critical reviews and comments.

Upon weighing these factors, I have determined, on balance, that it is contrary to the public interest to release the information.

Clause 17(c)

Documents 14a and 14b and Document 16 are Parliamentary Briefing Notes prepared for the purpose of the Minister's use in connection with Parliamentary investigation or debate and accordingly their disclosure is protected by Parliamentary privilege. These documents are considered exempt pursuant to clause 17(c) of Schedule 1 to the FOI Act.

Section 20(1)(b)

Document 01a and Document 02 has been refused access under Section 20(1)(b) of the FOI Act as this document is publicly available for inspection on the website of the Parliament of South Australia and the Department for Infrastructure and Transport. The links to the website have been provided in the attached document schedule for ease of reference.

If you are unhappy with this determination you are entitled to exercise your rights of external review with the Ombudsman SA. Alternatively, you can apply to the South Australian Civil and Administrative Tribunal (SACAT). If you wish to seek a review, you must do so within 30 calendar days of receiving this internal review determination. Thank you for your question raised in Parliament on Thursday 7 July 2022, inquiring as to whether the South Australian Government will upgrade the Murray Bridge to Mannum Road in anticipation of the opening of the new Thomas Foods International (TFI) facility at Murray Bridge later this year.

As you are aware, the Commonwealth and State Governments provided \$14 million in funding towards the construction of a new junction on Mannum Road, and a two-kilometre link road in support of the new TFI facility. This work was completed in December 2020, as you would recall from having attended the opening event along with the former Premier.

To support the broader freight industry, upgrades to Mannum Road and the development of the Adelaide Hills Freight Bypass route have been undertaken over several years. These upgrades include the heavy vehicle route and Cypress Terrace rail crossing by the Rural City of Murray Bridge.

Most recently, \$12 million in economic stimulus works funded by the Commonwealth and State Governments have contributed to the upgrade of three bridges, six bridge barrier sets, and shoulder sealing between Murray Bridge and Sturt Highway.

These works addressed the 'risk-based approach' audit findings, which have allowed Level 3A Performance Based Standards (A-double and B-triple combinations) to travel along this route since September 2017.

At this point in time, there is no requirement for further works along Mannum Road, nor the Adelaide Hills Freight Bypass route.

To align with the Infrastructure Australia Priority List 'South Australia High Productivity Vehicle network access' initiative, the Commonwealth and State Governments have jointly provided \$10 million—on a 50/50 basis—for the Greater Adelaide Freight Bypass Strategic Freight Study.

This study is investigating the requirements and infrastructure needs to run high productivity vehicles—Level 4A Performance Based Standards (A-Triple combinations)—within South Australia in future.

Thank you for taking the time to raise this matter with me in Parliament and I trust this information is of assistance

PURPOSE

- To respond to the Parliamentary Question asked on Thursday, 7 July 2022, by Mr Adrian Pederick MP, Member for Hammond, regarding whether the State Government will upgrade the Murray Bridge to Mannum Road.

BACKGROUND

- Mr Pederick states that *"the new Thomas Foods International facility at Murray Bridge is due to open later this year, which will result in a dramatic increase in road freight to the facility."*
- In support of the new Thomas Foods International facility, the Australian and State governments provided \$14 million funding towards the construction of a new junction on Mannum Road and a two-kilometre link road to the new site.
- Noise abatement treatment was also provided to a local residence.
- This work was referred to the Parliamentary Public Works Committee and completed in December 2020. These works were officially opened at an event attended by the dignitaries including the then Premier and Mr Pederick.
- Discussions with Thomas Foods International have indicated that traffic and heavy vehicle volumes will increase progressively over several years as the facility is developed to cater for other species.
- Previous works in support of the Adelaide Hills Freight Bypass route, including Mannum Road, have included the upgrade by the Rural City of Murray Bridge of their heavy vehicle route and the upgrade of the Cypress Terrace rail crossing.
- Most recently, the \$12 million Economic Stimulus works funded by the Australian and State governments have completed the upgrade to three bridges, six bridge barrier sets, and completed shoulder sealing between Murray Bridge and Sturt Highway.
- These works addressed the 'risk-based approach' audit findings which have allowed Level 3A Performance Based Standards (A-double and B-triple combinations) to travel along this route since September 2017.
- No further works are required along Mannum Road, nor the Adelaide Hill Freight Bypass route, in the short term.
- Further funding has been provided by the Australian and State governments for the Strategic Freight Study for the \$10 million Greater Adelaide Freight Bypass. This study is investigating the requirements and infrastructure needs to run high productivity vehicles – Level 4A Performance Based Standards (A-Triple combinations) – between State borders within South Australia in the future.
- The Strategic Freight Study will develop a business case for further infrastructure p

KEY POINTS

- The Department for Infrastructure and Transport together with the Rural City of Murray Bridge have progressively upgraded roads within the Council area to develop an Adelaide Hills Freight Bypass route.
- No further works are programmed along Mannum Road.

OFFICIAL

- A Strategic Freight Study is investigating the requirements and infrastructure needs to run high productivity vehicles – Level 4A Performance Based Standards (A-Triple combinations) – between State borders within South Australia in the future, which includes Mannum Road.

CONSULTATION

- An initial round of consultation associated with the Strategic Freight Study was completed in April 2022. This included consultation with Traditional Owners.
- This consultation was documented and was used as input into the early stages of the planning studies problem identification and options development / assessment.

I am advised by the Department for Infrastructure and Transport (the Department) that significant patching works have now been completed on all the high priority sections on Mannum Road.

I am further advised that works commenced on 27 October 2022—and were completed on 2 November 2022—near Randell Road and Patrick Road, at the Tepko-Mannum Road intersection, north-east of Reedy Creek Road, and north of Salt Creek Road. Further patching works are planned to be undertaken during November 2022 on the lower priority sections from Tepko Road to Wagenknecht Road, and Shaw Lane to Railway Road.

Other sections of Mannum Road that are in poor condition are scheduled for patching by the end of December 2022.

My correspondence to the Member for Hammond, Mr Adrian Pederick MP, dated 5 September 2022 was in response to Mr Pederick's specific concern about whether the Murray Bridge to Mannum Road would support the increased freight to the Thomas Foods International facility in Murray Bridge. My statement concerning further works to this route was in reference to major upgrades, not ongoing maintenance.

- On 29 August 2022, **Clause 6(1)** wrote to you regarding the condition of Mannum Road.

KEY POINTS

- Mannum Road comes under the care, control and management of the Department for Infrastructure and Transport and is in poor condition and requires major renewal works to avoid ongoing failures.
- A work order has been issued for the Mannum Road / Tepko intersection for the repairs of pavement failures that present a current safety risk at an estimated cost of \$15k. These works will be completed in October 2022.
- Further pavement patching works are programmed to be completed on Mannum Road by the end of December 2022, with an estimated costs in the range of \$50k to \$60k.
- Other recent maintenance works have included repairs of some 55 potholes and edge breaks since June 2022.
- Mannum Road, from south of the Tepko Road to north of Wagenknecht Road, is not listed in the current periodic maintenance resurfacing program.
- Mannum Road will continue to be regularly inspected with any minor repairs made to ensure the road is maintained in a safe condition for all road users.

Thank you for your correspondence to the Premier of South Australia, the Hon Peter Malinauskas MP, regarding the condition of Mannum Road from Mannum to Murray Bridge. As this matter falls within my responsibilities as Minister for Regional Roads, the Premier has asked me to respond on his behalf. I apologise for the delay in responding.

I am advised that the Department for Infrastructure and Transport (the Department) that it has undertaken works to upgrade the established Regional North-South Freight Route between Sedan and Murray Bridge to improve safety for road users, freight productivity, efficiency and network reliability.

This \$12 million package of works was jointly funded (80:20) by the Commonwealth Government and the South Australian Government as part of the Road Infrastructure Stimulus Package.

Works completed on Mannum Road as part of this project involved the construction and sealing of aprons on eight side roads to improve safety along the route. This included Wilkin Road, Salt Creek Road, Tepko Road, Maczkowiack Road, Abraham Road, Pfeiffer Road, Marks Road and Piggery Road. I am advised that these works were completed in early 2021.

Since the completion of these works, sections of Mannum Road deteriorated and were in poor condition, particularly the section from north of Tepko Road to north of Wagenknecht Road.

I am advised by the Department that significant patching works have now been completed on all the high priority sections on Mannum Road.

I am further advised that works commenced on 27 October—and were completed on 2 November—near Randell Road and Patrick Road at the Tepko-Mannum Road intersection, north-east of Reedy Creek Road and north of Salt Creek Road. Further patching works are planned to be undertaken during November 2022 on the lower priority sections from Tepko Road to Wagenknecht Road, and Shaw Lane to Railway Road.

Other sections of Mannum Road that are in poor condition are scheduled for patching by the end of December 2022.

I am advised that the Department's maintenance contractor will continue to inspect Mannum Road on a fortnightly basis and attend to repairs as they occur to ensure the road is maintained in a safe condition.

For issues requiring immediate attention, I encourage road users to contact the Department's 24-hour Traffic Management Centre on 1800 018 313. Calling this number to report an issue directly will result in a more timely investigation and repair, where required.
