

TRAM OPERATOR (Aboriginal and Torres Strait Islander Recruitment) PRE-SCREENING APPLICATION

The Tram Operator is responsible for the safe and efficient operation of light rail vehicles, across the Adelaide metropolitan tram network. Functions include driving, adhering to timetabled services, assisting customers with ticketing and fare queries and delivering excellent customer service to ensure passengers enjoy a safe, reliable and timely means of transport.

As a Trainee Tram Operator you will be provided with comprehensive training, a very competitive pay rate which rises as you become qualified and attractive leave provisions.

This is a safety critical role and requires all successful applicants to meet pre-employment assessments, along with an interview, satisfactory criminal history check, medical examination and reference checks. The Tram Operator must comply with 'zero tolerance' to alcohol and illicit drugs, and will be required to participate in mandatory random testing.

Applicants must be available to attend all recruitment and merit based selection stages from **March 2018 to July 2018**, in order to be considered for the role. All communication and invitations (e.g. psychometrics assessments and interviews) will be sent via email. Please ensure emails are checked on a regular basis during this period as notifications will be provided via email.
