I refer to your application made under the *Freedom of Information Act 1991* (the Act), dated 19 January 2023.

Your application seeks access to:

“Copies of all correspondence between the Minister for Energy and Mining’s Ministerial Office, or anyone employed in the Ministerial Office and Santos, or anyone employed at Santos, between March 24 2022 and December 31 2022.”

An extensive search was conducted within this office. A total of 13 documents were identified as answering the terms of your application.

I grant you access in part to 13 documents; copies of which are enclosed.




