The Minister has approved my qualifications and experience for registration as a Private Certifier pursuant to Regulation 91(1)(b) of the *Development Regulations 2008*. (A copy of the Minister's approval must be attached);

OR

I am seeking the Minister's approval of my qualifications and experience pursuant to Regulation 91(a1)(c) or 91(1)(b) of the *Development Regulations 2008*. (Comprehensive details of relevant experience and qualifications must be attached).

ELIGIBILITY TO PRACTICE
