

Key Business Feedback

Whilst it was great to have seen so much amazing scenery around this state, it was also good to see that the communication and relationships between the different agencies and the Facilities Managers is actively there, but there is room for improvement.

Some clients and sites are not fully engaging the Facilities Managers to help with the complete process of making modifications and additions to their sites, which in turn as part of this process SAMIS information is not being kept up to date and this is reflected in the site audits.

As you are all aware the SAMIS information/hierarchy, drawings and site plans need to be updated when there are onsite changes made to the assets. I found that the sites that had outdated SAMIS plans were due to the site completing onsite works themselves and not involving their FM in the process.

I heard stories, such as when a site had an after-hours fire and the fire brigade needed to locate the hot water service, as this was the a cause of a fire emergency, only to find that the site had made additions and modifications that the Facilities Managers were not involved with, hence the SAMIS plans, drawings and hierarchy had not been updated. The Firemen had trouble locating the hot water service and they nearly lost the building, which would have been devastating to the local community and a bigger expense to the State. Luckily a staff member was contacted who knew the facility well enough to assist with the location of the Hot Water service.

So please, I encourage that you work with your Facilities Managers and that all Facilities Managers make regular contact with the people at the assets they are working with, so that the potential risk is limited.
